CACHAGUA FIRE PROTECTION DISTRICT MINUTES OF THE REGULAR MEETING OF THE BOARD OF DIRECTORS Wednesday, June 11, 2025 CACHAGUA FIRE STATION – NASON RD., CARMEL VALLEY

The meeting was called to order at 6:01 P.M.

ROLL CALL: Eli Riddle present, Monty Salas-Cordrey present; Laura Stenvick present.

NON AGENDA: The barn was cleaned last Sunday. Bob Eaten noted that when the enclosure was built, the exterior power outlet was removed and requested that a new outlet be installed on the outside. He also stated that if the enclosure door is ever locked, a second set of keys should be made available to him. The board will be responsible for addressing both the lock and outlet matters. Suzi reported that equipment is being parked in front of the bay doors and emphasized the need to create a new fire lane to prevent this. Assistant Curry will check in with Bob regarding the fire lane design and report back.

CONSENT AGENDA

APPROVAL OF MINUTES: The minutes of the regular meeting of May 07, 2025, were considered. Motion to approve submitted by Stenvick; seconded by Salas-Cordrey; motion carried.

ACTION AGENDA

- 1. 2025-2026 Benefit Assessment Resolution for vote-Stenvick moved to adopt the resolution, with Salas-Cordrey seconding the motion. The resolution was adopted without changes to the assessment and will be submitted by the deadline.
- 2. Grant Updates- We are currently awaiting a response on our application. Aubrey Wardwell has met with Jamie and they are exploring additional grants for roadway work and building partnerships with large landowners, including the Esselen Tribal Council and Rana Creek. In regard to volunteer support and financials, Wardwell would like to explore how we can better support the Cachagua volunteers, particularly with budgeting and accounting. Wardwell is also beginning work on establishing a FireWise Community in our area and is looking to connect with anyone who is currently part of a Road Association, or anyone inspired to get involved. Building these relationships is key to getting this off the ground and coordinating fuel reduction and defensible space work across properties. Working with experienced individuals, such as Meredith May, would be very beneficial.
- 3. Visible Fire House Sign-The board has paid for the sign and put up on May 12.
