- 1. Updates and Collaboration for Grants and Fire Mitigation Efforts-Audrey Wardwell will be attending the Coastal Conservancy Webinar to gather information on how to apply. She also recommends collaborating with the district to develop a map showing available acreage for grazing, prescribed burns, and fire breaks—each marked in distinct colors for clarity. Additionally, she suggests researching grants to support cleanup efforts from previous years when Cal Fire assisted with fire breaks. Fire fuel management remains a key priority. Our goal moving forward is to establish and finalize a comprehensive district map.
- 2. Visible Fire House Sign- Sign works is producing our sign. More information to follow at next month's meeting.
- 3. CFCV Grant Updates- To date, \$500 has been utilized for training classes. The remaining funds may potentially be used for CPR classes or to provide training for high school students.
- 4. Cal Fire Grant- The applications, one signed and one unsigned, were submitted on 5/1/25. Now we wait to see if we are approved; the final amount was exactly \$20K. This will be a 50-50 grant if approved. Cal Fire has acknowledged receipt of the application.
